President Association Report

In June 2014, ALOSI - the Chilean Association of Independent Loss Adjusters - became IFAA's President Association, represented by its President Felipe Hoetz (photograph below). This is the first time that a Latin American country holds the Presidency. In the first half of his term, Felipe has travelled extensively and presented at conventions and seminars representing the IFAA.



At the 5th Educational London Conference, held in June at the Willis building, he was part of a panel, which was followed by a Q&A session and he made a presentation for the Conference's final comments (please click here to view it).

In July, he was invited to make a presentation at a seminar organised by Chile's Securities and Insurance Superintendence (SVS) and the Latin American Association of Insurance Supervisors (ASSAL) titled "Regulation and Supervision of Market Conduct". At this event, the U.S. National Association of Insurance Commissioners made a presentation titled "Regulation and Supervision of the Market Conduct in the United States" (please click here to view both presentations).

In August, Felipe was invited to make a presentation at the Annual Convention of Chile's Association of Banking and Retail Insurance Brokers.

In September, Felipe returned to London and he was invited to attend the 12th version of Swiss Re's Insurance and Reinsurance Conference in Mexico City.

He came back to London in October for the 2nd "Chile Insurance Day" after a successful first experience in 2013 in London and Miami. This event was held at Lloyd's and co-hosted by the Chilean Insurers' Association. Gabriel Anguiano, Latin America Market Development at Lloyd's was joined by Jorge Claude, Executive VP of the Chilean Insurers' Association and Mr. Carlos Pavez, Chile's Securities and Insurance Superintendent. Presentations were made regarding market conditions in Chile and the development of a claims cooperation/control agreement between the Chilean Market and Lloyd's (please click here to view the presentations).

Later that month, Felipe was invited to attend a seminar hosted by the Chilean Association of Brokers titled "Changes in the Insurance Market: Two visions". At the end of October, Felipe was invited to attend Munich Re's "Renewable Energies Seminar" in Buenos Aires, Argentina. In November, he was invited to attend Swiss Re's first webinar in Spanish, titled "Export Products Liability". In early December, Felipe is back in London to attend this year's last IFAA Board Meeting.

In the second half of the Presidency, Felipe will host the 6th Educational Conference in Miami, on the theme of Catastrophe Claims with a Latin American focus. This event will take place on May 19th and we are in the process of confirming key speakers and sponsors. He will also assist in promoting the 2015 FIDES Hemispheric Insurance Conference, which will take place in October in Santiago, Chile. For more information please visit www.fides2015.com
